Technical training and assistance to land trusts: build the capacity of Wisconsin land trusts and conservation organizations through one-on-one mentorship and technical assistance, conferences, and workshops. The "land trust education and advancement program" (LEAP) works intensively with selected land trusts to move them closer to accreditation by the Land Trust Alliance, a national association of land trusts. Since 2011 Gathering Waters has provided LEAP assistance to 20 land trusts across Wisconsin.

4b (Code:) (Expenses \$ 178,200 including grants of \$ 0) (Revenue \$ 5,640)

Education and public outreach: educate the general public, professionals, and landowners about the importance of private land conservation and voluntary tools available to set aside private land for conservation. Gathering Waters maintains an interactive website and publishes paper and electronic newsletters throughout the year.

Policy and government relations: work with decision makers at all levels of government to promote state, local, and federal policies that support the work of land trusts and the conservation of private land. Specifically, Gathering Waters advocates for continuation of funding for the Knowles Nelson Stewardship Fund, a program of public financial support for the preservation of land in Wisconsin.

Form 990, Part VI, Section B, Line 11b - The organization makes the Form 990 available to its Finance Committee, which includes members of the Board of Directors. The Finance Committee reviews the Form prior to filing.

Form 990, Part VI, Section B, Line 12c - The Associate Director collects and reviews conflict of interest statements completed by individual Board members annually, and communicates to applicable Board and staff members any potential conflicts of interest. Board members who have a conflict of interest are expected to excuse themselves from participation in deliberation about matters involving the conflict.

Form 990, Part VI, Section B, Line 15 - The Executive Committee of the Board of Directors authorizes the Executive Director's salary, based on information obtained from informally surveying compensation paid by comparable organizations, most recently in 2011.

Form 990, Part VI, Section C, Line 19 - Gathering Waters Conservancy makes its governing documents, conflict of interest policy, and audited financial statements available to members of the general public upon request.
