Technical training and assistance to land trusts: build the capacity of Wisconsin land trusts and conservation organizations through one-on-one mentorship and technical assistance, conferences, and workshops. The "land trust education and advancement program" (LEAP) works intensively with selected land trusts to move them closer to accreditation by the Land Trust Alliance, a national association of land trusts. Since 2011 Gathering Waters has provided LEAP assistance to 30 land trusts across Wisconsin. During 2014 Gathering Waters organized a training retreat for over 60 land trust staff and board members, and during 2014 sponsored a training session for land trust board members and a peer-to-peer gathering of land trust executive staff.

4b (Code:) (Expenses \$ 210,433 including grants of \$ 0) (Revenue \$ 3,915)

Education and public outreach: educate the general public, professionals, and landowners about the importance of private land conservation and voluntary tools available to set aside private land for conservation. Gathering Waters maintains an interactive website and publishes paper and electronic newsletters throughout the year. During 2014 Gathering Waters organized a statewide Awards Celebration attended by over 200 people interested in land conservation.

4c (Code:) (Expenses \$ 181,298 including grants of \$ 0) (Revenue \$ 0)

Policy and government relations: work with decision makers at all levels of government to promote state, local, and federal policies that support the work of land trusts and the conservation of private land. Specifically, Gathering Waters advocates for continuation of funding for the Knowles Nelson Stewardship Fund, a program of public financial support for the preservation of land in Wisconsin. Gathering Waters successfully advocated for continued funding of the Stewardship Fund during the 2015 session of Wisconsin's state legislature.
