You helped lay a strong foundation for the 2019 state budget battle

If the Governor and legislature cannot agree to keep the Knowles-Nelson Stewardship Program alive and well-funded in the 2019 state budget, millions of dollars for Wisconsin land and water protection will disappear-devastating conservation efforts statewide.

In 2018, you helped bring over 40 conservation-minded organizations together to discuss this threat and develop strategies for addressing it. You helped retain a professional lobbying firm to: be our eyes and ears in political circles; get us in the right meetings with the right people at the right times; and provide strategic counsel. You helped commission a poll confirming 93% of Wisconsin voters believe state funding of land and water protection should be a priority. You also helped launch Team Knowles-Nelson, to make it simple for concerned Wisconsin voters to communicate with their elected officials during critical times.


