Supporters rallied together and formed the Friends of Pelican River Forest.

Tireless volunteers took to the airways, wrote letters to the editor, and contacted elected officials. Wisconsinites demanded accountability.

Your support ensured local voices were heard through Team Knowles Nelson and facts were shared on a dedicated Pelican River Forest website.

The tremendous outpouring of public pressure forced dissenters out into the open.

The project faced numerous twists and turns. Last year, the Legislature's Joint Committee on Finance denied Knowles-Nelson Stewardship funding for the project in a party-line vote.

And the opponents didn't stop there. They actively distributed misinformation to town

officials and county boards to sow confusion and doubt about land protection.

Earlier this year, he authorized the DNR to finalize the project and accept federal Forest Legacy funding. Governor Evers then announced the protection of Pelican River Forest in his State of the State address in February.


You helped Gathering Waters reach a milestone!

college, Bill realized he wanted to work on conservation in Wisconsin.

His conviction was so strong that he traded a prestigious career at a Chicago law firm to start an environmental law practice in Madison.

True to his goal, Bill made a difference. He worked with

elected officials to pass the Uniform Conservation Easement Act in 1982. And, he helped establish more than two-thirds of Wisconsin's land trusts and drafted scores of land protection agreements.

Bill O'Connor was also one of the driving forces behind Gathering Waters.

In 1990, Wisconsin changed how it funded land protection projects.

Wisconsin's original conservation program — the Outdoor Recreation Act Program (ORAP) — had been in place since the early 1960s. There was a need to rethink how land protection was being funded.

Thanks to a bipartisan agreement, the Knowles-Nelson Stewardship Program was passed into law.

For the first time, state grant funding was provided to nonprofit land trusts, helping drive a rapid expansion of interest in private land conservation. By 1994, it became clear that Wisconsin needed a statewide organization to support this growing land trust community.

Visionary leaders, including Jean Meanwell, Robert Chambers, the late Harold C. "Bud" Jordahl, the late Geoff Maclay, and Bill O'Connor, came together to create a new land trust service organization known as Gathering Waters.

That was thirty years ago.

"It's been so gratifying for me to see how Gathering Waters has evolved over the years," Bill said. "For thirty years now, I've watched the organization mobilize the land trust movement

and preserve the Knowles-Nelson Stewardship Program."

The need for Gathering Waters is far from over.

In addition to the battles for state funding, Bill O'Connor sees other challenges on the horizon. One growing risk involves the intergenerational transfer of conserved property.

"Landowners spend hours working with land trusts to set the detailed terms in conservation easements," Bill said. "But as protected lands start to change hands, folks who inherit or buy these special places might not

share that same dedication to conservation.

"Some successor owners won't understand, and a few may flatout disagree with restrictions set out in conservation documents.

"We can expect disputes over land trusts' interpretation and even challenges to the validity of easements in the courts. This type of litigation is costly and could put a lot of pressure on land trusts' resources."

When legal challenges happen, your support gives land trusts a place to turn for advice.
